## QUALIFICATIONS FOR MEMBERSHIP

- 1. The candidate has accepted Jesus Christ as Lord and Savior.
- 2. The candidate is old enough and mature enough to understand what he or she is doing.
- 3. The candidate has followed the Lord in water baptism.
- 4. The candidate is in agreement with the Shoreline Community Church Constitution, "Statement of Faith" (see exception on back of this form), and Bylaws.
- 5. The candidate agrees to prayerfully support the church government and the ministry of Shoreline Community Church as it follows sacred Scripture.
- 6. The candidate is willing to submit to Matthew 18:15-17 in cases of ethical or moral sin, this with the understanding that church discipline is always done with the goal of healing, reconciliation, and restoration.
- 7. The candidate is approved by the Board of Elders for membership.

#### **VOTING RIGHTS**

Every active member has the right to vote on issues brought to the congregation by the Board of Elders.

For voting and affirmation purposes, active members shall be considered those members
who have attended church regularly for at least three months prior to any vote or
affirmation requested.

#### TERMINATION OF MEMBERSHIP

Members shall be removed from the church roll for the following reasons:

- 1. Personal request of the member.
- 2. Transfer of membership to another church
- 3. Death.
- 4. Dismissal by the Board of Elders when a member's life and conduct warrant removal from church membership. (NOTE: Membership may be restored upon demonstration of repentance and the approval of the elders.)
